




WHAT IS THE WHOLE HOUSING APPROACH?

The Whole Housing Approach (WHA) is an evidence-based framework for addressing the housing and safety needs of survivors of domestic abuse in a local authority area.

In 2022, Standing Together Against Domestic Abuse (STADA) partnered with Cheshire East Council to pilot all the WHA components in a single local authority for the first time.



MISSION

- Improve access to safe and stable housing for survivors
- Ensure access to a range of housing options and initiatives tailored for domestic abuse

AIMS


- Create earlier identification and intervention for domestic abuse through mobilising stakeholders across all tenure types
- Reduce the number of survivors made homeless
- Increase tenancy sustainment options
- Bring together the housing and domestic abuse sectors (coordinated community response)

The University of Lancashire conducted an independent evaluation of the pilot. Their full report and and executive summary of findings and recommendations will be available via the STADA website. This summary of key achievements has been prepared by STADA based on those findings.

WHAT DID THE WHA PILOT ACHIEVE?



MORE DOMESTIC ABUSE IDENTIFIED BY HOUSING PARTNERS



There was a year on year increase in referrals to the Domestic Abuse Hub from local authority housing teams, housing associations, sheltered housing, and supported accommodation

1,589 referrals in total



MORE SURVIVORS SUPPORTED TO REMAIN IN THEIR OWN HOMES



506

Homes secured through sanctuary scheme and target hardening

This is an average increase of

in installations from the year before the pilot began



SURVIVORS MORE LIKELY TO HAVE HOMELESSNESS PREVENTED

By the end of the pilot:



98%*

of survivors at risk of homelessness and owed support by the local authority were prevented from becoming homeless

Compared to 63% in the year before the pilot began



MORE SURVIVORS FEELING SAFE



There was a year on year increase in survivors who reported feeling safer after receiving local authority specialist domestic abuse support

COST BENEFIT

A thorough cost-benefit analysis found that the WHA is a highly costeffective intervention and offers exceptional social value.

For every £1 invested in the model

£10.20

in public sector savings is generated*

£1.20

is saved in directly attributable local authority housing costs for every £1 spent

WHAT DID SURVIVORS IN CHESHIRE EAST TELL US?

They were so understanding...nothing like any other Council I've ever been around

I'm no longer scared inside my house...I just can't wait to start this new life

ANNA'S STORY

Green path: The WHA interventions we delivered and associated costs

Red path: The likely outcomes and costs prevented or delayed

(costs calculated using the Greater Manchester Combined Authority Unit Cost Database) Anna* was living in supported accommodation and was experiencing domestic abuse from her partner. She experienced childhood trauma, which led to mental health problems and substance misuse. The perpetrator's mum was also presenting a risk to Anna.

Service charge arrears had accrued on Anna's accommodation, preventing her from moving to housing that would better meet her needs. Anna was receiving IDVA support, but her IDVA was struggling to engage her.

At this point, Anna was referred to the Multi-Disciplinary Team IDVA under the WHA.

Anna is engaging with drug & alcohol services and mental health support. She is working to cut ties with the perpetrator and is hoping to eventually attend college.

£1,400

Anna accessed Flexible Funding to clear the service charge arrears on her housing, enabling her to move to recovery accommodation.

Anna provided statements to the police to support the prosecution case against the perpetrator and perpetrator's mum. The perpetrator was imprisoned.

The MDT IDVA engaged Anna with support, completed safety-planning and helped her to understand the risks in her relationship.

£8,548

She is unable to maintain her tenancy, is evicted from her supported accommodation and makes a homeless application.

£4,948

Anna subsequently experiences a deterioration in her mental health and substance misuse.

£2,190

Total costs

Green £2,314

Red path: £15,686

She continues to be abused by the perpetrator and his mum.

Anna remains in her accommodation, which does not meet her needs.
